Visas and passports

Before you fly check the latest passport, visa, and health entry requirements on our [Visa and passport requirements](#) page.

Check-in

Find out how you can [check in for your flydubai flight](#). Our online check-in is available between 48 hours and 75 minutes before the flight departure time (from [selected destinations](#)). If you chose to check in online, at some airports you might still need to go to the airport check-in counter for us to verify your travel documents and issue your boarding pass. You'll need to arrive at the airport at least 3 hours before departure. Check-in closes 60 minutes before departure, boarding starts 45 minutes before your flight and boarding gates close 25 minutes before flight departure time. If you arrive late, you will not be accepted onto the flight.

Manage booking

You can use 'manage booking' to change your travel dates, add or remove a passenger, upgrade to Business Class or simply add optional extras. Please check the fare rules attached along with your booking confirmation to see the fees applicable for changing or cancelling your flight(s).

If your booking was made through a travel agent, please contact them directly to make changes to your booking. If you're booked as part of a group, please check with the group organiser for details on the fare rules, as they may differ from those listed on flydubai.com. For special service requests with our partner airlines please visit the partner airline website or contact their call centre.

Baggage allowance

Hand baggage rules

You may carry one item up to 7 kg in Economy Class or two items with a total of 14 kg in Business Class. Each item must not exceed 55 × 38 × 20 cm and must fit in the overhead locker. Within this allowance, you may carry one laptop bag, handbag or satchel up to 25 × 33 × 20 cm. Hand baggage that exceeds the allowance must be checked in and the baggage fee will apply. If storage on board is limited, you may be asked to check in your hand baggage at the gate.

Important: Remove valuables (e.g., money, jewellery, precious metals) or important documents (e.g., passports, ID, business papers) if asked to check in your hand baggage at the gate.

Checked baggage rules

You may check in up to 3 pieces of baggage within the allowance shown in your booking confirmation. Each piece must weigh under 32 kg and not exceed 159 cm (height + width + depth). Important: Do not place valuables (e.g., money, jewellery, precious metals) or important documents (e.g., passports, ID, business papers) in your checked baggage.

Wheelchair assistance

If you are travelling with your own wheelchair or require wheelchair assistance during your journey with us, please inform us at least 24 hours prior to your flight departure and before checking in online. While all reasonable measures will be taken to fulfill your request, we cannot fully assure these requests will be met, even if confirmed in writing. Credit/debit card payment

If the payment for this booking was made using a debit or credit card and the cardholder isn't travelling on this itinerary, flydubai might ask for a photocopy of the cardholder's credit/debit card and valid ID document at the airport check-in desk for verification purposes.

If you are unable to present the required documents at the airport, you won't be allowed to travel, and we won't be able to offer you a refund.

Transferring between Dubai International (DXB) and Dubai World Central (DWC) and vice versa

If your travel itinerary requires a transfer between the airports in Dubai, you'll need to enter the UAE (clearing customs and immigration) and collect your checked baggage. Please check whether you need a visa to enter the UAE and ensure you have sufficient time to travel to your departure airport.
